MB reported back the three options:	
'(1) MOBRA owns and rents equipment to race directors. This is likely	
to be very expensive (>\$5,000) and requires someone to handle the	
logistics.	
(2) MOBRA uses Big Shark as a go-between to rent equipment to	
race directors. MOBRA owns very little equipment anymore and a	
sizable investment in new equipment would be needed.	
(3) MOBRA doesn't do anything until we receive feedback from the	
2014 race season.	
Proposed solution was to write-off MOBRA's existing equipment	
inventory and assess need for supporting promoters after the end of	
the 2014 season. Note: Big Shark has traditionally let other	
promoters borrow their equipment. It is expected that Big Shark will	
start charging for equipment. Rental rates will be below existing	
market rates.


